3. List of Superintendents retired from 2000 to 2022 are given in two list as **Annexure 3 (upto 2009)** compiled out of the records available in this office and **Annexure 3 (from 2010)** as per the available records. . However the cadre in which they have joined the department cannot be given as the particulars will be available only in their service records which are maintained by different Commissionerates in the zone.
4. List of Officers working as superintendents in Chennai Zone who joined the department as Inspector in the year 1985 to 2005 is readily not available as it pertains to information which is more than 20 years back
5. List of Officers working as Superintendents who joined the department as Inspector on the basis of all India Merit List is not available as neither the disposition list nor the seniority list maintained in the zone does not indicate the cadre in which each officer has joined the department
