With regards to the details of exemption given for one arm disabled person in computer typing test in Central Government job, Sl.No.13.8.11.6 (pageNo.19) of SSC Notification 2022 dated 17.09.2022 ( [https://ssc.nic.in/SSCFileServer/PortalManagement/UploadedFiles/notice\\_CGLE\\_17092022.pdf](https://ssc.nic.in/SSCFileServer/PortalManagement/UploadedFiles/notice_CGLE_17092022.pdf) ) clearly specifies that

“except for the post of Tax Assistant in CBDT, for which exemption for DEST (Data Entry Speed Test) is available. All other PwD candidates are not available for exemption from DEST.”
