Point No. 1: From the Date of Judgement i.e., 27.11.2012.

Point No. 2: No. This office has implemented the N.R. Parmar judgement from the revised panel drawn by the Review DPC held on 15.05.2017. For the vacancy year 2011-12(Supplementary), the Promotees have been inters-paced with the 2011 DRs.

Point No 3 & 4: This office had already implemented OM dated 11.07.2002 from 2002 onwards and hence requirement to conduct review DPC did not arise. Further the OM dated 10/08/2020 was clarification to OM dated 31/01/2005 and 11/07/2002.

Point 5 & 6: DPC do not implement the judgment of the courts during the promotion unless instruction are issued by Board/DOPT to implement judgment.

Point No. 7: Catch up Rule have not been implemented for preparation of Seniority List in the grade of Superintendent and Administrative Officer in this Zone.
