TRADE NOTICE NO. 02/2026-GRC

Sub: Grievance Redressal Committee (GRC) for the State of Tamil Nadu – Change in the names of three Member Associations – Amendment to Annexure 'A' of Trade Notice No. 06/2025-GRC

Ref: Trade Notice No. 06/2025-GRC dated 23.09.2025 issued vide F. No. GCCO/TECH/TPS/OTH/20/2020-TECH

Attention of the Trade, Industry, field formations and all other stakeholders is invited to Trade Notice No. 06/2025-GRC dated 23.09.2025, whereby the Grievance Redressal Committee (GRC) for the State of Tamil Nadu was re-constituted for redressal of grievances of taxpayers on GST related issues, and the Trade Associations and Associations of Tax Professionals nominated to the GRC were notified in Annexure 'A' thereto.

2. Three of the Member Associations nominated to the GRC have since intimated changes in their official names, duly supported by documentary evidence. Accordingly, in partial modification of the aforesaid Trade Notice, Annexure 'A' thereto stands amended as follows:

- i. In the Table titled "*Representative of various Trade Association as per Para 3*", against Sl. No. 1, the name "*MSME Welfare Association, Madurai South*" shall be substituted with "*Tamilnadu MSME Welfare Association*";
- ii. In the Table titled "*Representative of various Trade Association as per Para 3*", against Sl. No. 2, the name "*Federation of Madurai Manufacturers & Trade*

Associations, Madurai" shall be substituted with "Federation of Manufacturers & Traders Associations of Tamilnadu (FOMTA)";

- iii. In the Table titled *"Representative of prominent Association of Tax Professionals as per Para 3"*, against Sl. No. 2, the name *"South India Tax Practitioners' Association, Madurai"* shall be substituted with *"GST and Income Tax Practitioners Council"*.

3. It is clarified that the above amendments are consequent upon change in the names of the said Associations only. The constitution, membership, functions, mandate, term and all other contents and terms of Trade Notice No. 06/2025-GRC dated 23.09.2025 remain unchanged.

4. All Trade Associations and Associations of Tax Professionals are requested to bring the contents of this Trade Notice to the notice of their respective members and constituents.

5. This is issued with the approval of the Principal Chief Commissioner of GST & Central Excise, Tamil Nadu & Puducherry Zone.
